



Training on Legal Alignment – Negotiating Chapters 11 and 12

19 - 21 April 2017, Danilovgrad (Montenegro)



Background

The legal alignment with the EU Acquis has been recognized as one of the key priorities in the area of European integration of candidates and potential candidates for EU Membership. The Regional School of Public Administration (ReSPA) has organised a number of trainings and workshops dedicated to the topic of legal alignment. These workshops were general in nature covering the methodology and technics used for transposition of the Acquis into national legal systems and related planning processes. However, following recommendations by its beneficiaries, ReSPA now intends to organise a training which would be related to some concrete acquis chapters.

Content

The training will cover two negotiating chapters of the EU acquis Chapter 11 – Agriculture and Rural Development and Chapter 12 – Food Safety, Veterinary and Phytosanitary. The training will focus on few examples of legal transposition and preparation of negotiating process for given chapters. The main legal concepts and principles covered by the two referred chapters will be explained and elaborated. The training will be interactive and based on real or simulated examples of the use of transposition techniques and methods. The training is expected to be more practically focused than theory oriented.

Target Group

The target audience are civil servants from the European integration central coordinating institutions in charge of acquis transposition and other line ministries and administrative bodies in charge of transposition of negotiating chapters 11 and 12 or preparation of NPAA.

Given the interactive nature of training, no translation will be provided, participants a required to be fluent in English.

Methodology

The workshop trainers will use power point presentations for all of the topics envisaged in the programme. This will enable the participants to follow the intensive analysis as well as participate in the discussions for each block of presentations. Certain time will be allocated for interaction amongst trainers and participants. During the workshop several practical exercises will be conducted to put into practice theory learnt before. This will enable both, trainers and participants, to learn from each other.

Training will be delivered by Ms. Ružica Gelo and Ms. Sanja Šeparović who have extensive experience in legal transposition, NPAA development and accession negotiations related to the negotiating chapters 11 and 12.
