The Peer Exchange Workshop will gather governments, CSO representatives and experts from the Western Balkans (Albania, Bosnia and Herzegovina, Montenegro, North Macedonia and Serbia) with related country who is an active member of the Open Government Partnership i.e. with high-levels of performance at OGP.

The overall aim of the event will be to discuss and exchange and share experiences about open government reforms in different countries. The workshop will focus on two main themes: Open State and Public Service Delivery.

Organisers: ReSPA (Regional School for Public Administration), OGP, in collaboration with selected country.

Theme 1: Open State

This theme will explore current synergies and collaborations happening beyond the executive level (Legislative, Judicial, and Subnational levels) in selected OGP country/ies and Western Balkans.

A) Session on Open Justice

- Judicial Processes / Transparency of Statistical Information of the Judicial Branch
- Justice open portal
- Access to justice

B) Session on Open Legislative

- Lessons and challenges on opening national congress data
- Experience on transparency of the parliament

Theme 2: Public Service Delivery

This theme shall be used to share examples of inspiration and best practice solutions in open government and public service delivery in selected OGP country/ies and Western Balkans and to foster collaboration, innovation and knowledge sharing and explore scaling up those best practices, locally and regionally.

A) Open Data to Deliver Better Services

The local government experience with the Public Works Observatory, improving the delivery of public services in health, education and transport areas, as well as

promoting openness of data, transparency and interoperability between different levels of administrations

- Add Western Balkans experiences such as e-Safe Albania, e-Participaton BiH, and other Latin American experiences

B) Better service delivery for inclusion

- Possible topics of interest: water management commitment, representation of people with disabilities in service delivery design, Open Municipalities, Open Government Culture, Online procedures and services, etc.
- Collaborative projects with the vulnerable groups as beneficiary, inspiring cases both at the local and central level
- Add Western Balkans experiences from Skopje (N. Macedonia) as one of the local governments of the OGP, from Montenegro, from Serbia and other local government experiences

C) Budget transparency, data exchange and accountability

- Possible topics of interest: promoting openness of data, proactive transparency and interoperability between different levels of administrations
