Background

Following the first meeting of Better Regulation (BR) Working Group (WG) for year 2021 which was held remotely (online) on 25 February 2021, ReSPA will organize the second annual meeting of the WG. The meeting will be held in a face-to-face mode **in Ljubljana on 21**st **of October 2021**, starting at 14.00. The meeting will be focused on Citizens' and civil society empowerment and engagement in the policy and legislative development.

In the EC 2020 Enlargement Package it is noted that in the enlargement countries, there has been some progress with *improving policy planning*, but further efforts are needed to *ensure a strong quality control* by central governments. In addition, it is emphasized that policies, legislation and public investments are still often prepared *without impact assessments*. In addition, for a number of administrations in the Western Balkans, it is noted that still implementation of public consultation remains unsatisfactory, especially at local level, while meaningful and systematic consultations remain to be ensured. Some progress has been achieved to train line ministries to better use public consultations, although, for some administration, a methodology on public consultations is not yet in place. Can be noted that most of the administrations have developed an electronic web-portal for public consultations, but their use by the public remains limited.

In this regard, during the WG Meeting ReSPA will focus, among others, on identification and presentation of best example models from European Union, in the domain of public consultation and engagement with civil society. In addition, five representatives of Civil Society Organizations (CSOs) from different countries of the Western Balkans, will present their assessment of the quality of public consultations in their respective countries and future perspectives. This will boost the dialogue among CSOs representatives and members of the Working Group and will enhance exchange of practices and ideas as well as identification of good examples from the Region.

The meeting will also serve as a forum for presentation of ReSPA Programme of Activity in the coming months (thematic areas related to Center of Government and Better Regulation) as well as for the presentation of the results of the Monitoring process of ReSPA Activities. Any other topic related to Better Regulation can be discussed during the meeting, upon proposal of any of the WG Members!

Colleagues from OECD/SIGMA will also join the meeting.
