Aim and Purpose of the Meeting

The main objectives of this meeting are:

- to highlight the role of ReSPA Liaison Officers from BiH in the implementation of new EC grant, and
- to define in a precise manner the Application form for In-country Support Mechanism for Bosnia and Hercegovina.
