PROTOCOL OF COOPERATION ON THE CREATION OF THE REGIONAL SCHOOL OF PUBLIC ADMINISTRATION

The representatives of the Republic of Albania, Bosnia and Herzegovina, the Republic of Croatia, the former Yugoslav Republic of Macedonia, the State Union of Serbia and Montenegro along with the Republic of Montenegro and the Republic of Serbia, the United Nations Interim Administration Mission in Kosovo (UNMIK) acting on behalf of Kosovo pursuant to United Nations Security Council Resolution 1244, in presence of the European Commission;

Recalling the importance for the Stabilization and Association Process of strengthening regional cooperation and administrative capacity, as pointed out in the "Thessaloniki Agenda for the Western Balkans" endorsed by the governments of the region and the Council of Ministers of the European Union in June 2003;

Recalling also that the same document specifically encouraged the creation of a regional mechanism fostering training and education for public administration;

Have agreed as follows:

I - Cooperation objectives

- 1) This Protocol establishes the Regional School of Public Administration (hereafter: ReSPA), aiming at:
 - a) improving regional cooperation in the field of public administration;
 - b) strengthening administrative capacity as required by the European integration process;
 - c) developing human resources in line with the principles of the European Administrative Space.
- 2) Initially ReSPA has the form of a network, as further described in this Protocol.

II - Activities

- 1) The Parties maintain contacts amongst their institutions responsible for public administration training and education, facilitating the sharing of information and experiences through activities including but not limited to:
 - a) Stimulating cooperation between public administration institutions from the region and similar institutions in the European Union, as well as participation in international networks;
 - b) Holding seminars and summer/winter schools for public administration professionals, as well as an annual conference for public administration training and education institutions;
 - Acting as a catalyst for trans-national communities of practice, through the implementation
 of training by mobility schemes allowing public servants to gain experience of different
 contexts;

- d) Sharing information resources through the publication of a newsletter, the creation of a joint electronic library, and the issuing of other specialised publications such as training materials.
- 2) The Parties also participate in joint projects of mutual interest aiming at direct improvements in the training and education for their public administration. Such activities may include but are not limited to:
 - a) Developing methodological guidelines based on good practice for training and education programs, and encouraging innovation by reviewing existing ones;
 - Strengthening the research base of training and education for public administration through joint study groups for comparative research on topics of immediate interest;
 - Advising on the strengthening of the institutional framework for the management of quality training and education for public administration, including under the auspices of the network;
 - d) Improving the availability and quality of training and education by delivering, in cooperation with national institutions, high quality programmes on issues relevant to the European integration process.

III - Governance structure

- 1) The Steering Committee is responsible for governing ReSPA, according to its Rules of Procedure. Each Party to this Protocol undertakes to establish an effective system for reporting to its government on progress towards the objectives in article I.1), achieved through participation in the Steering Committee.
- 2) Each Party to this Protocol and the European Commission appoints one member of the Steering Committee and one substitute member. In the case of the State Union of Serbia and Montenegro, each of its two constituent Republics appoints one member, while the respective substitute member is appointed by the State Union.
- 3) The Steering Committee which meets maximum four times per year to review progress and decide on future activities, according to article II.

IV - Technical assistance

- 1) The Parties shall seek support from the European Community for ReSPA through technical assistance, including the funding, in particular on the basis of the CARDS and IPA programmes, for an initial two-year period of its activities and of a Secretariat assisting the Steering Committee in its responsibilities.
- 2) ReSPA coordinates and pursues maximum synergy with other organisations sharing similar objectives, whether financed predominantly by the European Community (e.g. the SIGMA programme) or through other sources (e.g. the NISPAcee network).

V - Final provisions

- 1) Within two years from the entry into force of this Protocol, the Parties will consider further institutionalisation of their cooperation, including participation by all Parties in the funding arrangements, initially covered by article IV.1.
- 2) This Protocol enters into force upon signature and remains valid for each Party unless terminated by written three-month advance notice to the other Parties.
