

Preparatory Meeting on Study on Integrated Planing Systems in Western Balkans Administrations

28 March 2023 National Academy for Public Administratoin Belgrade, Serbia



Aim and Purpose of the Meeting

In 2021 ReSPA developed national studies on policy coordination in its members and Kosovo^{*1} and organized several workshops and one regional Conference devoted to this topic. Thanks to these studies, seminars, and conferences, the regional network of policy coordinators was established, and a comprehensive regional academy on evidence-based policymaking was launched. Following these achievements, in 2023, ReSPA plans to enlighten specific topics related to the functioning of the integrated planning systems (IPS) in Western Balkans administrations as a logical step forward.

IPS constitutes a wide range of planning and monitoring functions designed to ensure that the government's central policy and budget processes operate coherently, efficiently, and in an integrated manner. The functioning of the IPS ultimately should create substantial and consistent policies that are affordable, economically efficient, and financially sustainable. It should include consultation with relevant domestic and international stakeholders. Through IPS, planned reforms/policies should help the governments in more accessible and faster achievements of the priorities related to entry and membership in the European Union. IPS should ensure that all public policies are developed, implemented, communicated, and appropriately monitored. Also, appropriate IPS supports the transposition and implementation of the EU Acquis in all sectors. It helps integrate and coordinate public investments from the domestic budget with EU support and other international development partners' funds.

The level of development and implementation of IPS in Western Balkan administrations differs. Therefore, the introductory meeting of the Regional network of policy coordinators with selected experts is a necessary preparatory step for producing the overarching Study on integrated planning systems in Western Balkans.
