on EU Accession Negotiation – Chapter 29: Customs Union

21-24 June 2021 (Online)



Background

The 2021 Seasonal School on EU Accession Negotiations is hosted by the Regional School of Public Administration (ReSPA), in cooperation with European Commission DG TAXUD "Taxations & Customs" and CEFTA Secretariat.

This School is devoted to Chapter 29 – Customs Union. The event is a unique opportunity for teams dealing with EU accession negotiations from across Western Balkans administrations to come together, connect online, exchange views, network, share ideas, and discuss current and future challenges related to the accession process in specific Chapter 29.

In this regard, the specific purpose of the Seasonal School is to **improve the knowledge and professional skills** of participants dealing with EU affairs related to the Chapter 29 – Customs Union of EU Accession Negotiations process and to provide them the opportunity to network with colleagues from the region who already developed important experiences in negotiations.

What to expect?

This Seasonal school on EU accession negotiation is particularly devoted to challenges in accession negotiation of Chapter 29 – Customs Union. This Chapter is in cluster 3 Competitiveness and inclusive growth. Two of ReSPA Members (Montenegro and Serbia) already negotiate accession to the EU. There were no opening benchmarks for this Chapter in the case of Montenegro and Serbia. Both countries have three closing benchmarks, similar in structure and content: to continue to adopt legislation in the remaining areas requiring further alignment, apply its customs rules consistently and efficiently across its customs offices, and reach sufficient progress in developing all the required IT interconnectivity systems. At the same time, two ReSPA Members (Albania and North Macedonia) are waiting on opening the negotiation process, this topic is very interesting for their administrations. Also, for the representatives of governments of BiH and Kosovo* this topic is very attractive.

All presentations at the School will be delivered for the most relevant **experts from DG TAXUD**, and in addition to that, **CEFTA experts will present the results of the work of this organization in the area of trade facilitation**.

The objectives of this ReSPA Seasonal School on EU Accession Negotiations:

- To deepen the knowledge on the accession negotiation process and negotiation technics, and understanding of the issues covered by particular negotiation Chapter 29 Customs Union;
- To equip participants with concrete experience from Montenegro and Serbia with lessons learned on dealing with opening negotiation and work on closing benchmarks related to Chapter 29;
- To build connections among participants for future regional cooperation, because the improvement of regional cooperation is fundamental to the accession process of the regional aspirants for EU membership.





Who shall attend?

This Seasonal School will bring together representatives of governmental institutions (Ministries of Finance, Customs offices, Ccordiantion structures established for the EU accession negotiations process from Albania, Bosnia and Herzegovina, Montenegro, North Macedonia, and Serbia, senior to mid-level professionals). They have or will have an active role in ongoing or future accession negotiation processes. The participants from Montenegro and Serbia will take an active part in presenting their experiences.

Joining us online

Due to the restrictions caused by the Covid-19 pandemic, this year Seasonal School on Accession Negotiations will be organized online through the Zoom Platform.
