Background

In order to enable governments to plan and execute well-defined policies it is essential to ensure that a policy development cycle is well-structured and comprehensively established.

The complexity of governance can be seen as the need for the interlinking various problems and policies faced by governments. Therefore, the policy co-ordination is more and more important topic for improvement. This is leaded by need to ensure whole-of-government co-ordination in order to mitigate and diminish objectively existing divergences between sectoral priorities and policies.

Governments of Western Balkan countries have developed important steps in establishing basic legal and institutional framework for improved co-ordination of various public policies. Beside this, the policy co-ordination includes the specific structures, responsibilities, mandates and capacities of these structures to carry out these responsibilities. Obviously, the governments still need to develop (and implement) more effective and inclusive methodological frameworks, institutional mechanisms to address policy interactions and co-ordination across sectors within the government.

ReSPA Programme of work 2020-2021 defined the objective to contribute to more efficient implementation of public administration reform in the region by strengthening policy co-ordination, especially the co-ordination among PAR and PFM strategies. Following that, in 2020 ReSPA engaged an international expert to develop the Analytical paper on Policy Co-ordination in Western Balkans. As a follow up of this study, ReSPA engaged six national experts to develop specific analyses on policy co-ordination in each of Western Balkan countries. Their tasks are to present the strategic, legal and institutional aspects of coordination of public policies, with thoroughly explained the role of the most relevant public administration institutions in improvement of co-ordination among public policies. The important segment of these analyses is the set of policy recommendations.

Magdalena Shaldeva, as engaged expert for study on policy coordination processes in North Macedonia, drafted this analytical document, and the presentation and discussion on it will be organized at the upcoming workshop which will be held on 28-29 September 2021 in Ohrid.
